BY-LAW 2018-18

"A BY-LAW TO AMEND BY-LAW 2016-85 TO REGULATE THE KEEPING OF ANIMALS IN THE TOWNSHIP OF EDWARDSBURGH/CARDINAL"

WHEREAS the Municipal Act 2001, SO 2001, c. 25, Section 103, authorizes the municipality to pass by-laws providing for the seizure and impounding of animals;

AND WHEREAS the Municipal Act 2001, SO 2001, c. 25, Section 150 authorizes the municipality to pass by-laws for licensing, regulating and governing any business carried on within the municipality;

AND WHEREAS the Council of the Corporation of the Township of Edwardsburgh/Cardinal deems it desirable to amend By-law 2016-85;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh/Cardinal enacts as follows:

- 1. That Section 53 under the "PENALTIES" heading is deleted and replaced by the following:
 - "Every person who contravenes any provision of this by-law is guilty of an offence and upon conviction is liable to a fine as provided for in the Provincial Offences Act, R.S.O. 1990, c. P 33, as amended."
- 2. That the following Section 54 under the "PENALTIES" heading is added: "A person who is convicted of an offence under this by-law is liable for each day or part of a day that the offence continues, where the minimum fine shall not exceed \$500.00 and a maximum fine of \$10,000.00 and the total of all daily fines for the offences is not limited to \$100,000.00 as provided for in Section 429(3) of the Municipal Act, SO 2001, c. 25, as amended."
- 3. That Section 54 is renumbered as Section 55.
- 4. That Section 55 is renumbered as Section 56.
- 5. That Section 56 is renumbered as Section 57 and amended as follows: "Upon registering a conviction for a contravention of any provision of this By-law, the court in which the conviction has been entered, may in addition to any other remedy and to any penalty imposed by this By-Law, make an order prohibiting the continuation or repetition of the offence by the person convicted, pursuant to Section 431 of the Municipal Act 2001, SO 2001 as amended."
- 6. That Section 58 be added to the "PENALTIES" section as follows:
 "Every person who contravenes this by-law, including a notice to
 remedy issued under this by-law is guilty of an offence."
- 7. That Sections 57 through 61 under the "OTHER" section be renumbered 59 through 64.
- 8. That By-law 2016-85 be amended to include Schedule "F" Set Fines attached hereto.
- 9. That all other provisions of by-law 2016-85 shall remain in force and effect.
