This addendum has been issued on March 25,2025 to summarize and answer questions received since March 21, 2025.


1) Will the Township provide a legal fabric for property ownership and the ROW limits?

Part A, bullet three, requires the development of a base and survey plan which will establish property lines and ROW limits for this project.

2) Can you please clarify the limits of resurfacing on Legion Way?

Please see answer below which was issued in Addendum # 2 on March 21, 2025

Topographic surveying and resurfacing will only be for the roadway connecting Dundas/Legion Way to Legion Way where resurfacing hasn't been completed.

3) Where will addendums be posted?

Addendums are being posted at <u>Bids and Tenders - Township of</u> <u>Edwardsburgh Cardinal</u> and emailed to potential bidders. Addendum # 1 was issued on March 19, 2025 and Addendum # 2 on March 21, 2025.

4) As part of the feasibility and/or design, are upgrades or expansions to any watermain proposed? If not, can you please confirm that like-for-like replacement of old materials with new materials is the intent?

The intent is for like-to-like replacement of old watermain materials with new materials on Dundas Street West.

5) Is there a target date for tendering the project?

Addendum # 1, question 4, indicates the anticipated construction schedule to be 2026.

6) Can electronic submission of proposals be permitted?

Addendum # 2, question 1, states the Township will not accept email submissions for Project # RFP-EC-ES-25-04. Submissions shall follow the requirements outlined in the proposal.

7) Does the 10-page limit include the cover page or table of contents

The cover page and table of contents are not included in the 10-page limit.

8) The extent of watermain to be addressed is given in meters. Are there estimates or descriptors available for the extent of storm and sanitary sewer and forcemains to be addressed (either verified, replaced or rerouted in any way)

Part A, bullet 4 requires the mapping of the storm main catchment zone which will help determine the project limits for storm water. CCTV inspections for storm and sanitary mains, along with the feasibility study results to potentially relocate sanitary infrastructure will assist in establishing the project limits.

9) The RFP includes an approximate scope drawing on Dundas Street. Addendum 2 includes an addition map for Legion Way. The RFP suggests a forcemain coming from as far as the water plan. Can you please confirm what infrastructure, and the full extents of that infrastructure within the context of Objective #1 on page 3 of the RFP.

One of the purposes of this project is to establish the project limits for stormwater and sanitary infrastructure rehabilitation. Modifications or extensions to the existing force mains that connect into manhole B 217 may have to be considered based on the location and design of the new sanitary infrastructure.

10)Uder scope of work, Part A, please confirm the feasibility is limited to scenarios listed within the RFP, and additional scenarios are not required. Alternatively, if the successful proponent believes another scenario may be superior, should it be included as an assessed option, with feasibility and costing provided. Please specify a maximum number of scenarios for even bidding purposes.

For purposes of costing and even bidding for this proposal the feasibility study will be to evaluate if the sanitary main between 2031-2039 Dundas Street can be rerouted to Henry, William or Lewis Streets. If the successful bidder has additional scenarios that may be superior to the identified options listed, we can negotiate these terms at a later date.

11)Under scope of work, part A, what is the anticipated deliverable for providing the recommendations beyond submission of a report? Will a delegation to a council meeting or town hall be requested?

The deliverable for this project will be a report and engineered design drawings. We do not anticipate a delegation to Municipal Council will be required. Staff will prepare and present an information or action item to Municipal Council with recommendations.
